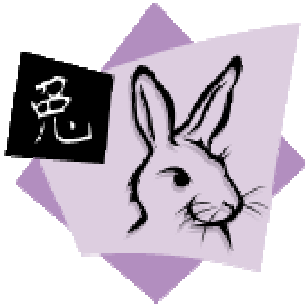

State Council Update

The last meeting of the 2010 Board was held in November at the Shore Break Hotel in Huntington Beach. A special orientation session for new chapter and committee leaders was held prior to the Board meeting on Thursday. Here are some of the highlights of the Board meeting.

Treasurer's Report

Kara attended an **ENA Treasurer's conference call** on October 20, 2010. She will report on the outcome of the conference call at the March State Meeting.

2011 Budget Preparation:

Budgets are NOW DUE to Louise. Each Chapter must submit ASAP as 2011 budgets need to be completed before the end of the year. Board approval is needed for 2011 expenditures.

Goals/Objectives for 2011 include:

1. Track monthly rosters for state council and active local chapters.
2. Provide roster-tracking education to foster recruitment and retention by individual chapters. Instruct chapter representatives in the creation and maintenance of a chapter database for monthly editing and label generation.
3. Participate in the chapter and state leadership orientation each fall with a membership component.
4. Focus on recruitment and retention efforts for Cal ENA through guidance and resource to any and all members; join the cooperative team of information resources as a new state committee that meets with the chapter representatives prior to each state council meeting.
5. Challenge each chapter to appoint a **Chapter Membership Coordinator** to track local members, manage local new and renewing members and enhance communication among members.
6. Coordinate Cal ENA Pre-paid Membership Awards statewide from January 1 through April 30, 2011.
7. Set goal of 4,100 state members in 2011 to celebrate ENA's 41th anniversary.

Chapter News

Trauma

2010 was a year of growth in the committee. Following the January ceremony thanking John Fazio and Anita Ruiz-Contreras for their years of hard work on behalf of the committee we began to move in new directions, knowing we could never fill their shoes! Our first step was to set goals for the committee work for the year, focused on growing more TNCC resources throughout the state and helping underserved areas grow programs.

The four regional director positions on the committee are meant to provide assistance to TNCC course directors and instructors in each of four loosely defined geographic areas of the state. During the course of 2010 we said goodbye and thanks to Angela Shannon and Anna Valdez as they moved in new directions. We welcomed Vicki Dippner-Robertson, Palm Springs, as South regional director in January, Sue Fortier, San Luis Obispo, as Central director in August and Judy Cline, Chico, as North director in November. We're still in need of a regional director in what is referred to as North Metro (the San Francisco Bay area). Regional directors are TNCC course directors and faculty, and are expected to help out with troubleshooting, monitoring instructor candidates, answering questions, promoting and supporting new courses, and helping with quality assurance issues. However, it turns out that our directors still need to complete their faculty process in 2011 before they're fully independent to teach instructor courses (another goal!) Once we've completed that then we can move ahead with our original goals of teaching instructor classes and growing the state's programs. If you find you are in need of help or run into a problem please contact me and we'll point you in the right direction.

In 2010 we assisted several underserved areas with course development. Kern County chapter received TNCC funds, as well as El Centro Regional Medical Center and Sierra Vista Regional Medical Center in San Luis Obispo. In December 2010 ENA awarded each state \$1000 for the Pediatric and Trauma committees to use in further spreading programs. We've already approved a request for assistance to help Northern Inyo Hospital in Bishop, a critical access hospital that serves the eastern area of the Sierra Nevada range. Another goal is to post the application for grant funding for underserved areas on the Trauma

page of the Cal ENA website this year (www.calena.us)

Following a successful run, CATN will no longer be available after April 30, 2011. ENA has already formed the new workgroup to create a successor course to CATN, which is estimated to take 2-3 years. Each student attending a TNCC generates a \$15 return from ENA to the Trauma Committee, to be used to further the work of the committee. At the end of each year, the remainder over \$10K is returned to the state council. At the end of 2010 a check for \$41,500 was sent to the 2011 Treasurer Kara Davis.

We are in the midst of creating a statewide list of monitors – those who have been approved by the committee to oversee an instructor candidate during their first monitored course. If you have served in this role, or wish to, please contact me. Our goal is to be able to post this list on the Cal ENA website for easy access. Contact info gdodgern@roadrunner.com

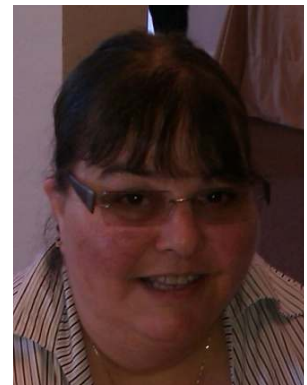

Trauma Committee Invitation

Your Trauma committee has had an enlightening and quite busy year entertaining ideas for better methods of spreading the “word”. We’ve realized that our resources are limited due to the lack of experienced instructors and facilities willing to sponsor courses. Our immediate plan for the new year is to provide instructor courses, with the goal of increasing our statewide instructor pool. We will follow up with strong, effective mentoring for several TNCC classes. With this larger source of instructors, the needs can more easily be achieved. Many hospitals

require TNCC verification, as is evident with the numerous daily calls pleading for classes. We’ve also examined our regions and are considering changing some of the geographical boundaries. With the success of 2010 TNCC classes, our committee was able to return to our State Council a check for \$40,000 and we were able to provide grants to assist hospitals launching their own TNCC classes. We are energetically recruiting folks to attend our illustrious committee meetings and can promise great fun while achieving our challenges!!
